**A Resolution Approving and Endorsing the Proposed Implementation of a Hybrid Learning Modality for the Second Semester of Academic Year 2025–2026, for Submission to the Appropriate University Authorities**

**WHEREAS**, Quezon City University recognizes the need to provide flexible and accessible learning arrangements that respond to the academic needs and circumstances of its students;

**WHEREAS**, a hybrid learning modality may combine face-to-face instruction with appropriate online learning methods, providing flexibility while maintaining academic engagement and continuity;

**WHEREAS**, the proposed implementation may support students who face legitimate challenges in attending fully face-to-face classes while allowing academic activities to continue without unnecessary disruption;

**WHEREAS**, the implementation of a hybrid learning modality requires clear academic guidelines, appropriate faculty coordination, adequate learning resources, and consideration of the University's facilities and technological capacity;

**WHEREAS**, the proposed modality shall be designed to maintain the quality of instruction, learning outcomes, student participation, and academic requirements prescribed by the University;

**NOW, THEREFORE BE IT PROPOSED**, that Quezon City University approve and endorse the **proposed implementation of a hybrid learning modality for the Second Semester of Academic Year 2025–2026** for submission to and consideration by the appropriate University authorities;

**PROPOSED FURTHER**, that the appropriate University offices establish the guidelines, schedules, conditions, and academic requirements governing the implementation of the proposed modality;

**PROPOSED FURTHER**, that faculty members and concerned offices coordinate to ensure consistent delivery of instruction, assessment, attendance, and other academic requirements under the approved modality;

**PROPOSED FINALLY**, that this Resolution shall take effect immediately upon its approval by the appropriate authorities of Quezon City University.

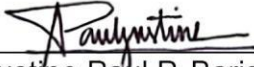
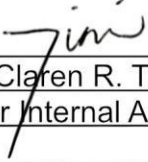
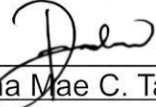
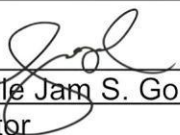
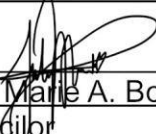
